Adequate time is devoted in redressal of complaint. 4. During grievance redressal meeting and entire process the members of grievance committee remain calm, cool and patient. 5. Effective, sensitive and confidential communication is ensured between all involved. 6. All possible steps are taken to ensure that no victimization occurs as a result of the grievances. 7. All the parties are heard and those who have been complained by other are also given an opportunity to respond. 8. In the investigation all relevant information is heard. 9. All the members of the grievance redressal cell follow documentation of the procedures, all necessary steps are taken to resolve the problems/complaints. Normally, the redressal pertains to addition of new books in library, cleanliness of washrooms, addition of new sports, etc.</p>
